
### PROPOSAL DESCRIPTION

- This is a proposal to convert the existing single family residence at 4921 South Shields Street to a Group Home use for older adults with memory or cognitive impairment for up to seven residents, with staff support provided.
- Changes to the building's interior are proposed to create a total of 5 bedrooms.
- Off-street parking on the property is proposed using the existing access from Shields Street.
- The site is located in the Low Density Residential (RL) zone district.
- This proposal will be subject to a review and public hearing by the Planning & Zoning Board (P&Z).
- Residents who receive this letter will also receive a letter for the P&Z hearing.
