620 W. Horsetooth Rd. – Wireless

<u>Telecommunications Facility</u> (Please see project location map on the back of this letter)

PROPOSAL DESCRIPTION

- Build a bell tower to house wireless antennae.
- Tower would be 65' tall.
- Ground equipment would be located in 40' x 40' area and screened with a fence.
- The site is in the Low Density Residential (RL) zone district.
- This use is not allowed in the RL zone
- Therefore, this proposal is subject to the Addition of Permitted Use (APU) process.
- This proposal would go to the Planning & Zoning Board (P&Z) for a recommendation to City Council for approval or denial.
- Residents who receive this letter will also receive a letter for the P&Z and Council hearings.
