

NEIGHBORHOOD MEETING INVITATION

July 17, 2015

On Thursday, July 30, 2015, from 7:00 to 8:30 p.m., at the Southgate Church, 6541 South College Avenue, the City of Fort Collins Planning Department will conduct a neighborhood information meeting to discuss a development proposal in your neighborhood. The project is referred to as Mountain West Landscapes and Home Site at 6805 South College Avenue.

As proposed, the project consists of redeveloping the property at 6805 South College Avenue in such a way as to preserve the existing house and the home-based landscape business east of the irrigation ditch and create one new lot for the future construction of one single-family detached home west of the ditch. The proposal is two-fold. First, the request is to establish the home-based landscape business as a permitted use on the property. Second, the request includes a *Project Development Plan* to subdivide the property to create one, new, three-acre lot west of the irrigation ditch for a new house.

Per the City's Land Use Code, a home-based landscape business is not listed as a permitted use in the L-M-N, Low Density Mixed-Use Neighborhood zone district. Therefore, the applicant is requesting an Addition of Permitted Use to allow a home-based landscape business shop and yard on this parcel only. Please note that the request is specific to the subject parcel only and would not result in re-zoning the parcel, and would not result in a home-based landscape business on any other property in the L-M-N zone city-wide.

Both the Addition of Permitted Use and the Project Development Plan must be considered by the Planning and Zoning Board at a future public hearing.


