This letter is being sent to let you know about Colorado State University's proposal to build a parking lot, located south of the new stadium between West Lake Street and West Prospect Road, and to invite you to the neighborhood meeting where you can learn more about the proposal. Specific information about this development proposal is to the right and on the back of this letter.

You received this notice because records from the Larimer County Assessor's Office indicate you own property near the proposed development site. Because of the lag time in recordkeeping, or because of rental situations, some neighbors may be missed. Please feel free to notify your neighbors of the neighborhood meeting so they can attend. If you own or manage an apartment building, please post this notice in a common area so your residents can participate.



CSU Lake and Prospect Parking Lot Site Plan Advisory Review (SPAR) (Please see project location map on the back of this letter)

PROPOSAL DESCRIPTION

- This is a proposal to construct a new surface parking lot at 615 West Lake Street and 634 & 626 West Prospect Road.
- Approximately 115 parking spaces are proposed.
- Primary access is taken from West Lake Street to the north, with secondary access to West Prospect Road to the south.
- The site is located in the High-Density Mixed-Use Neighborhood (H-M-N) zone district.
- This proposal is subject to a Site Plan Advisory Review (SPAR) by the Planning & Zoning Board.
