## PROPOSAL NAME & LOCATION

CSURF "Parcel B" Interim Parking Lot and Contractor Laydown Area. Please see map location on the back of this letter.

#### PROPOSAL DESCRIPTION

- The parcel is owned by the Colorado State University Research Foundation (CSURF), and is approximately 17 acres.
- The proposed plan includes an approximate 5 acre "contractor laydown" area to be used for the temporary storage of construction materials related to nearby CSU construction projects.
- The proposal also includes a recycled asphalt parking lot with approximately 205 parking spaces to be used on an interim basis (three years) to temporarily replace CSU parking removed from areas on campus.
- The proposal may include several modification requests to the City Land Use Code in conjunction with the temporary parking lot including parking lot interior and perimeter landscape requirements.
- This project is subject to review and approval by a City of Fort Collins Hearing Officer and is located in the Employment zone district.
