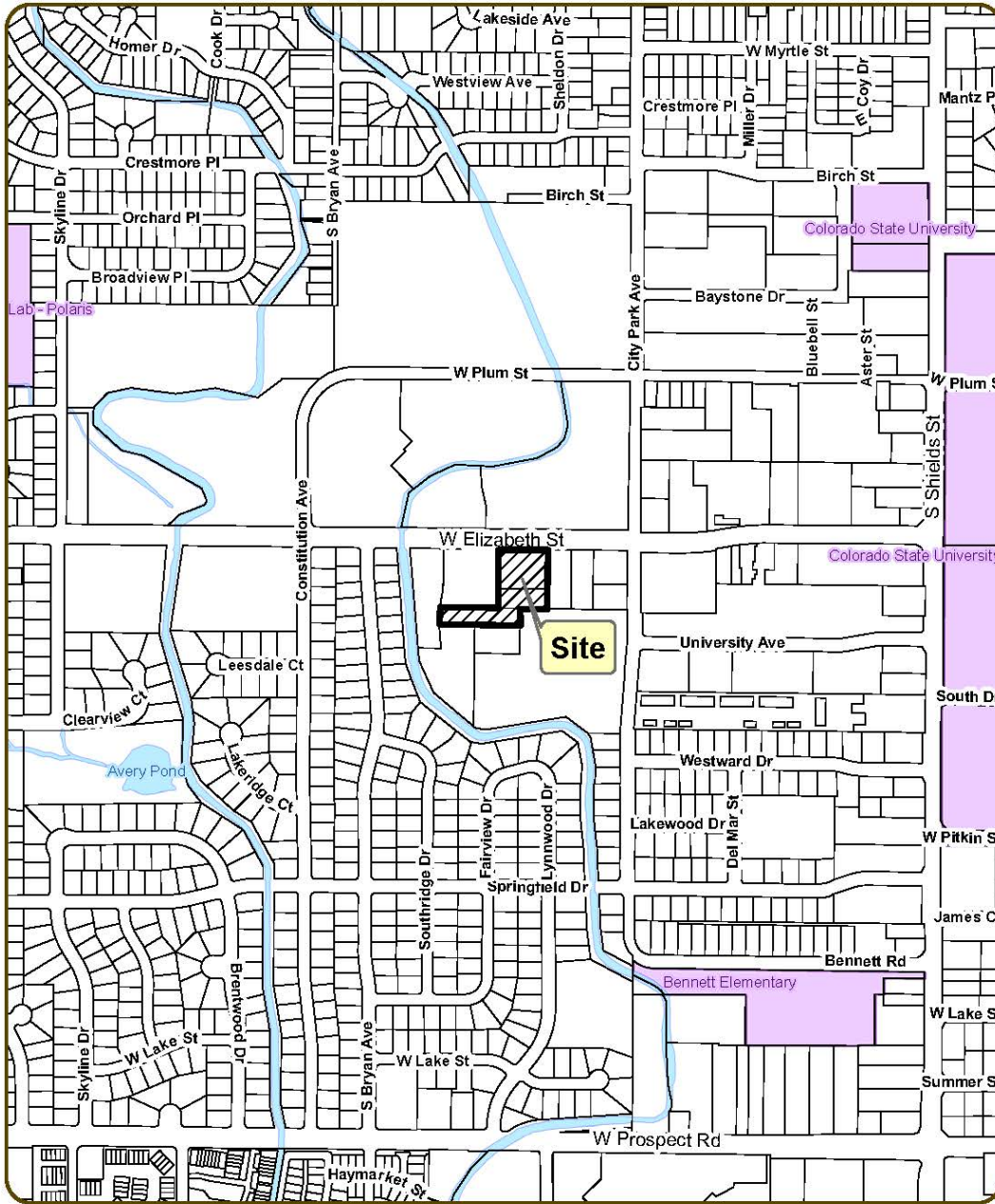

PROPOSAL DESCRIPTION

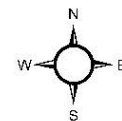
- Approximately 2 acre site, located at the CB Potts property at 1427 W. Elizabeth Street
- The existing CB Potts buildings are proposed to be demolished.
- Proposed housing: 223 student housing apartments in 1, 2, 3 and 4-bedroom units. A total of 396 beds are proposed.
- Building is proposed to be 5 stories.
- 314 parking spaces are proposed in a parking garage structure attached to the building.
- Retail space is proposed along the Elizabeth Street frontage.
- The site is zoned Community Commercial (C-C).
