On Monday, May 18, 2015, from 7:00 to 8:00 p.m., in Eagle Room One of the Northside Aztlan Community Center, 112 Willow Street, the City of Fort Collins Planning Department will conduct a neighborhood information meeting for a development proposal in your neighborhood. The project is referred to as **New Belgium Brewery Office Expansion**, **Medical Clinic and Beer Garden**.

As proposed, the two-story office expansion would extend southeast from the existing office area. The proposed beer garden would be located in the area of the existing visitor parking lot. The medical clinic would be located in front of the Packaging Hall. The request will be processed as a Minor Amendment.

This letter is being sent to let you know of a potential development proposal near your property and to invite you to the neighborhood meeting, where you can learn more about the proposal. We welcome and encourage your participation, as your input is an important part of the development review process.
