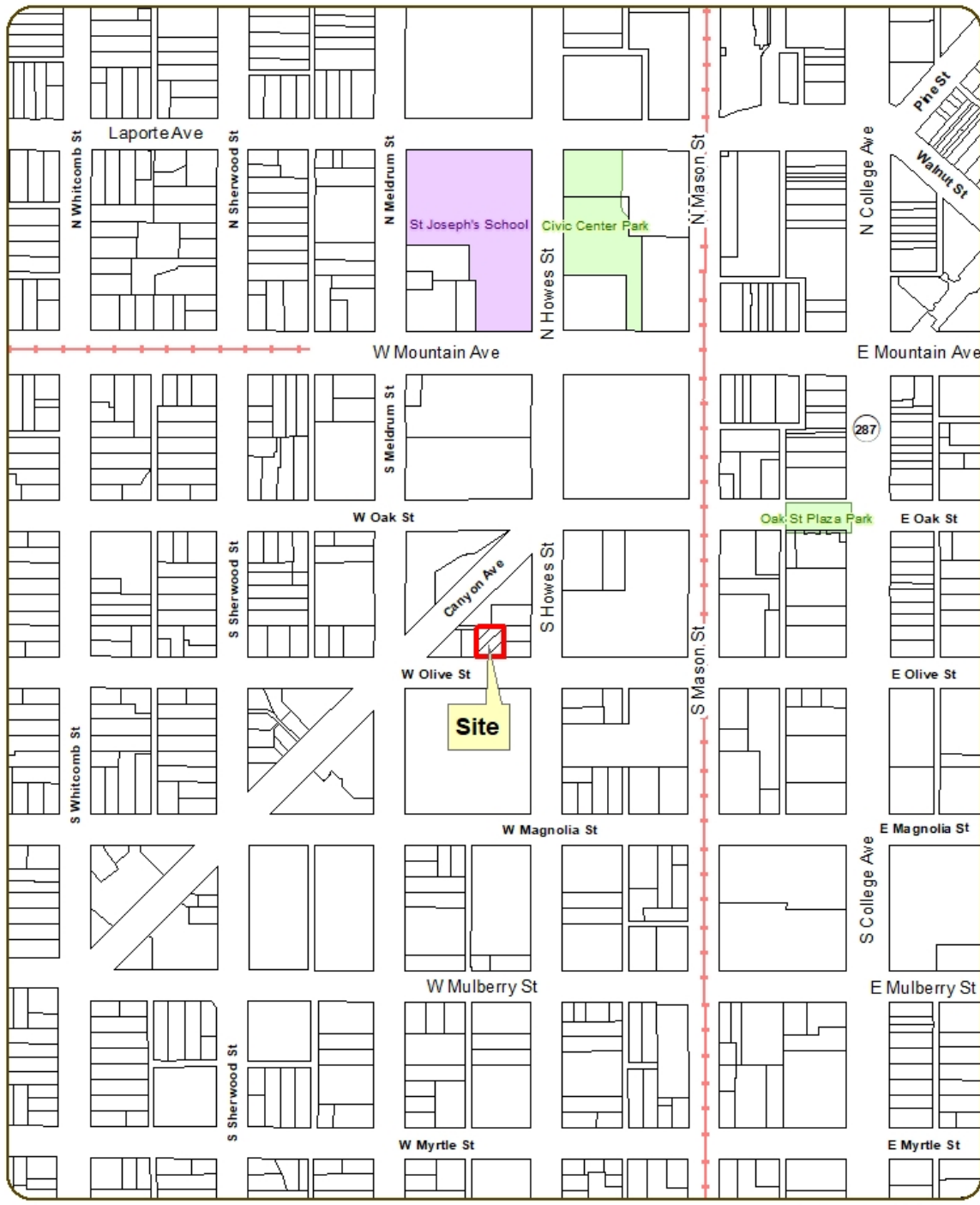

## PROPOSAL DESCRIPTION

- This is a proposal to develop a three-story, multi-family residential project on approximately .223 acres.
- Proposed development will include 7 dwelling units for sale, with a range of 1–2 bedroom units (11 bedrooms total).
- 8 parking spaces will be provided on site.
- Primary access is off West Olive Street and one-way private drive to Canyon Ave.
- The site is in the Downtown (D) zone district.
- This proposal will be subject to a review and public hearing by the Planning & Zoning Board (P&Z).
