

## PROPOSAL DESCRIPTION

- This is a proposal to redevelop the property currently housing Saint John XXIII Catholic Church at 1220 University Avenue and will also include redevelopment of the former gas station along Shields Street.
- The project will contain the new church, 3 student housing buildings, a parking garage and auxiliary parish space.
- A total of 600 bedrooms are proposed. Affordable rental housing is being considered with the project for a portion of the dwellings.
- The developer is also looking at options to provide surplus parking in the parking garage that would be available to the public. An additional parking garage level is being considered to help accommodate this additional parking. The additional parking level would require the approval of a Modification to the Land Use Code.
- The site is located in the Community Commercial District (CC) zone district and is subject to approval by the Planning & Zoning Board (P&Z) at a public hearing. Residents who receive this letter will also receive a letter for the P&Z hearing.
