
Development Plan 223 Willow Street (Please see project location map on reverse)

PROPOSAL DESCRIPTION

- This is a Project Development Plan (PDP) for a two-acre site on Willow Street. A concept plan will be presented at the meeting for approximately 190 to 200 residential dwellings.
- Two 5-story buildings are proposed.
- 170 to 190 parking spaces are proposed.
- The property is zoned (R-D-R)
 River Downtown Redevelopment
 District and is also in the Transit Oriented Development Overlay
 Zone (TOD).
- Primary access to the site will be from Willow Street.
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.
