Dear Property Owner or Resident:

On Thursday, March 14, 2019, from 6:00 to 7:30 P.M., at the Westminster Presbyterian Church, 1709 West Elizabeth Street, the City of Fort Collins Planning Department will hold a neighborhood information meeting where you can learn more about a development proposal in your neighborhood. The project is referred to as **Purpose Living House Residential Group Home at 2800 West Elizabeth Street**.

This is a request to convert an existing single-family residence to a group home at 2800 W. Elizabeth Street for the housing of a maximum of eight clients recovering from issues related to alcoholism. While tenants would not be receiving in-home treatment, the residents would live with a house supervisor employed by Purpose Living, LLC. The house is 2,782 square feet including five bedrooms and two baths. Four off-street parking spaces will be provided including one designated for the house supervisor. The applicant does not anticipate any exterior building alterations or any increase in impervious area. The parcel is zoned Low Density Residential (RL) zone district and the request is subject to Planning and Zoning Board review.
