ALLEGATIONS:

- 1) According to the 2020-07-31 ethics complaint, pdf page 80, Gutowksy announced as early as 2020-04-29 with the statement, "as I am preparing to run for re-election!". The ethics board ruled that this was not an announcement, so Gutowsky cannot claim here that such was her announcement and that the 60-day window to file a complaint expired.
- 2) According to the "COMMITTEE REGISTRATION/TERMINATION FORM" on the City 2021 Election Web Page, Gutowsky announced as late as 2020-12-21.
- 3) According to the definition of "Public announcement" per 7-132, "Registration of a candidate committee" constitutes a public announcement per the definition of "Candidate" in 7-132. On 2020-12-21, a candidate committee was registered for Gutowsky. The registration may be found null and void due to my 2021-01-27#1 complaint, but until such time the committee registration is registered as evidenced by the UNOFFICIAL CANDADITE section on the City's April 2021 election page.
- 4) In either 2 or 3 above, there is absolutely no legally compliant CANDIDATE AFFIDAVIT on file for Gutowsky for District 1 for the 2021-04-06 election properly filed within 10 days of the announcement or registration.
- 5) There is an incomplete CANDIDATE AFFIDAVIT that failed to specify both a district and an election. No one knows from the incomplete CANDIDATE AFFIDAVIT what office/district or election the affidavit is for. It would appear the City Staff assumed due to their personal knowledge and thus the sitting council member received a benefit not afford to strangers. By failing to properly disclose her candidacy for D1/2021 via a completed CANDIDATE AFFIDAVIT within the 10-day window, Gutowsky is disqualified.
- 6) Additionally, the incomplete CANDIDATE AFFIDAVIT dated 2020-12-21 and the campaign web-site announcement of, "I am seeking a second term as your District 1 City Council both constitute declaration of candidacy in a public place. See (2) under 7-132 definition for public announcement (includes social media) and 7-132 definition of social media (includes website). I found both these documents on websites, one on the City, one on susan-gutowsky.com, the site that now appears on the city election page. Please note that the 2019 committee was terminated on or about 2019-05-07, and as such the existence of both susangutowsky.com (name on 2021 committee registration, created 2020-12-21 per whois output below) and susan-gutowsky.com (active campaign page that susangutowsky.com points to, see curl output below) are further public announcements of her candidacy. susangutowsky.com is registered with GoDaddy, a fee-based service, and thus registration was required prior to buying this service, thus the affidavit was required no later than 10 days after the GoDaddy purchase. There is no affidavit dated 2020-12-31 (ten days after 2020-12-21) or earlier indicating Gutowsky is a candidate for D1/2021. Gutowsky is thus disqualified.

NOTE: Even though the typical browser will block the redirect from susangutowsky.com to susan-gutowsky.com, command line tools such as curl spell out the redirect so that it can be done manually. Thus even though there is a hack or config error causing the security error, which prevents automatic redirect, both command line tools and browsers provide manual overrides. Thus, it is still an announcement that is a public place.

7) All other candidates were able to properly complete the form and Gutowsky did properly complete the form in 2019. There is no excuse for an incumbent who got caught breaking the rules in 2019 and helped write and pass the new rules for 2020 to make such a mistake. Gutowsky is responsible for properly completing the forms and turning them in on time. Her failure to file a proper affidavit on time has given her an unfair

advantage over any other candidates that might declare. In fact, her unfair advantage may have scared off prospective candidates already. The only remedy for this bias, accidental or otherwise, that is fair to all other candidates, is disqualification.

CONCLUSION:

As Gutowsky did not file the proper affidavit for D1/2021, within 10 days of registering her candidate committee and making multiple public announcements and making campaign expenditures, she is disqualified from the election. As the Council Member is clearly checked on the affidavit and clearly stated on her web-site and in the ethics complaint, the disqualification is from D1/2021.

The City must take this complaint seriously and deny leniency that would show support for White Privilege and systemic racism.

I believe Gutowsky could still become a candidate in 2021 for Mayor, but not for any Council Member Seat.

FINAL NOTE:

Anything other than disqualification creates election irregularities that many are complaining about at the national level. It is critical that the City avoid getting caught up in this.

APPLICABLE LAW:

Sec. 7-132. - Definitions.

Candidate shall mean any person who seeks nomination or election to the office of Mayor or Councilmember at any City election. A person is a candidate IF THE PERSON HAS PUBLICLY ANNOUNCED AN INTENTION TO SEEK SUCH ELECTION or has filed nominating petitions for the office of Mayor or Councilmember. Candidate shall also mean any elected official who is the subject of recall proceedings pursuant to Article IX of the Charter.

Public announcement shall mean:

- (1) REGISTRATION OF A CANDIDATE COMMITTEE; OR
- (2) A statement made by the candidate signifying an interest in, or exploring the possibility of, seeking the office by means of a speech, advertisement or other communication reported or appearing in public media or in any place accessible to the public, including social media, that a reasonable person would expect to become public.

Social media shall mean any electronic medium, including an interactive computer service, application, or data network, that allows users to create, share, and view user-generated content, including but not limited to videos, still photographs, blogs, video blogs, podcasts, instant messages, electronic mail, or internet website profiles.

Sec. 7-133. - Candidate affidavit; disclosure statement; failure to file.

- (a) When any individual becomes a candidate, such individual shall certify, by affidavit filed with the City Clerk within ten (10) days, that the candidate is familiar with the provisions of this Article.
- (b) Each candidate shall file a financial disclosure statement pursuant to \$ 2-636 with the City Clerk at the same time as filing an acceptance of nomination.
- (c) Failure of any person to file the affidavit or disclosure statement required under this Section shall result in the disqualification of such

person as a candidate for the office being sought.

(d) The requirements of this Section shall not apply to any elected official who is the subject of recall proceedings.
