

FORT COLLINS MUNICIPAL COURT
SCHEDULE OF FINES

This Schedule, consisting of eleven (11) pages, is hereby adopted, **effective November 1, 2015**.

Please note that the non-traffic misdemeanor portion of this Schedule is printed directly from the Court's computer Code Table. Consequently, only those sections of the Code of the City of Fort Collins ("City Code") that have been cited in recent years (or which the prosecution has asked to have listed) are listed. Others sections will be added to the Code Table and this Schedule as they are used.


Fine increases: Fines listed in this Schedule are typical for first offenses unless higher penalties are requested by the prosecution due to aggravating circumstances. As to non-traffic misdemeanor violations, if a second non-traffic misdemeanor offense occurs within one year, the fine is doubled. For a third such offense, the fine is quadrupled. The maximum fine on any charge is set out in Section 1-15 of the City Code.

As to parking violations, Parking Services is hereby authorized to charge an increased amount for violations if not paid or contested within 8 calendar days. The increase shall be as follows:

\$10.00 fine increases to \$20.00,
\$25.00 fine increases to \$50.00,
\$35.00 fine increases to \$50.00,
\$50.00 fine increases to \$75.00,
\$75.00 fine increases to \$100.00, and
\$100.00 fine increases to \$150.00.

Bonding instructions: If an officer has grounds to believe that a defendant charged with a non-traffic misdemeanor will not appear in court, by his/her failure or refusal to sign the ticket evidencing his/her promise to appear in court or other reasonable grounds, the officer may require the posting of a cash or surety bond pursuant to this Schedule. Personal recognizance bonds will be allowed with court approval or pursuant to guidelines approved by the court.

Credit for jail served: If a defendant who has been convicted of a misdemeanor is later found in contempt of court for willful failure to pay an outstanding monetary balance due to the Court, said defendant shall be credited at a rate of \$50.00 per day for each day of jail served. In no event shall such imprisonment exceed ten (10) days.

III. Civil Infractions:

Violations of the City Code designated as civil infractions for first and second violations within 12 consecutive months are typically punishable as follows:

1st civil infraction within any 12 month period - \$100.00

2nd civil infraction within any 12 month period - \$300.00

Exceptions:

Animal violations:

Section 4-94, Animal Disturbance; and

Section 4-140, Impound Fees:

1st civil infraction within any 12 month period - \$175.00

2nd civil infraction within any 12 month period - \$350.00

Occupancy and Property Maintenance violations:

Section 5-264, Certificate Required for Occupancy in Excess of Limit;

Section 5-265, Posting, Inspection of Books and Records, Occupancy Disclosure;

International Property Maintenance Code, Section 106.3 – Failure to Comply w/Notice;
and

Land Use Code, Section 3.8.16 - Occupancy Limits:

1st civil infraction within any 12 month period - \$500.00

2nd civil infraction within any 12 month period - \$1,000.00

Note: The City Code provides that these violations are considered to be misdemeanors if they are third or subsequent violations within 12 consecutive months. Consequently, the Court's Code Table, and therefore this Schedule, lists the sections with an extension of "MD" for use when entering such offenses.
