6mm Compound aluminum composite, 1.5" sidewalls. Mounted on preasure treated 2x4 which are mounted to existing building wood face. Carriage icon will be painted to face, as will boarder striping. Letters will be 1/2" PVC mounted in from behind sign. All paint will be Sherwin Williams paint SW 6907 Forsythia (yellow) and SW 9100 Umber Rust (brown).



Small Accent Lettering (additional 3.18 sqft): Option A: Hand painted letters directly on building face trim areas. Option B: Flat cut 3mm Compbond painted to match sign.
