This letter provides you with certification that proposed work to your designated Fort Collins landmark property, work affecting the Wishing Well within the site of the Heritage Courtyard Landmark district, has been approved by the City's Historic Preservation Division (HPD) because the proposed work appears to be routine in nature with minimal effects to the historic resource, and meets the requirements of Chapter 14, <u>Article IV</u> of the Fort Collins Municipal Code.

The alterations reviewed include:

• Removal of the wooden structure covering the Wishing Well – Structure's materials to be stored in FCMOD offsite collection storage for potential future reconstruction and/or material analysis, and associated documentation made available for public reference.

Notice of the approved application has been provided to building and zoning staff to facilitate the processing of any permits that are needed for the work. Please note that work beyond that indicated in your permit application/correspondence requires additional approval.

If the approved work is not completed prior to the expiration date noted above, you may apply for an extension by contacting staff at least 30 days prior to expiration. Extensions may be granted for up to 12 additional months, based on a satisfactory staff review of the extension request.

## Hello Historic Preservation office,

Please see the attached information associated with the wishing well and the wooden pavilion covering the well. As you know, it is our desire to remove the wooden pavilion covering the well to gain better visual, and therefore physical access to the new entrance of the Carnegie Creative Center. Our options to achieve our desired outcomes were: 1) remove the pavilion and leave the stone portion of the well in place or 2) move the well and the pavilion to another location. The latter option would run the risk of damaging both the well and the pavilion.

Attached is photo documentation of the wooden pavilion as well as supporting materials and design review application. The photos include construction details and it's current condition. If our request is approved we intend to keep all associated paperwork, documentation and materials as part of the museum's inventory. By doing so, these materials will be preserved and can be researchable to the public if there is future interest in the information whether it be for possible reconstruction or material analysis or any other currently unforeseen opportunity.

As part of the courtyard construction project the Museum is planning to do a survey of all of the historic objects including the cabins. Included in this survey will be an evaluation of the current signage in the courtyard. As appropriate signage will be updated to reflect a more complete and accurate interpretation. In the case of the well, it will be an opportunity to deepen the interpretation and to highlight the importance of WPA supported projects that included the museum and the well. This will also give us an opportunity to explain that the pavilion was removed for practical needs and ongoing preservation.

We appreciate you consideration of this request and ask that you need further information to please reach out to me.

## Wishing Well: Carnegie Building

**Request from Cheryl D, May 26, 2023**: "Could you ... track down the history of the wishing well at the Carnegie and the roofed structure that was built around it? I'm specifically looking to see if a group like the Questers or DAR paid for it/built it. Jim would like to have it removed because that structure (not the well) it is impeding the new entrance to the Carnegie Creative Center. I'd appreciate someone doing a deep dive for us."

**Input from Lesley**: "When Linda looked into the history of the objects in the courtyard a few years back ... she noted that the <u>well</u> was built with leftover sandstone from the Pioneer Museum project, which would date it to about 1941. The linked image [see images below] indicates that the little structure around it was at least there in 1950s. The well was moved with the rest of the courtyard things during the construction of the Old Town Library from 1975-1977. There may be more information to dig into in the admin files for the museum, in the <u>ADMIN</u> [Museum Administrative Records] or <u>FCMS</u> collections [Fort Collins Museum Scrapbooks], maybe also in the <u>Clyde Brown</u> collection, or in the <u>Giddings book</u>, and museum vertical files. We may have to call some boxes in from storage."
