This letter provides you with certification that proposed work to your designated Fort Collins landmark property, the Northern Hotel at 172 N. College Ave has been approved by the City's Historic Preservation Division (HPD) because the proposed work appears to be routine in nature with minimal effects to the historic resource, and meets the requirements of Chapter 14, <u>Article</u> <u>IV</u> of the Fort Collins Municipal Code.

The alterations reviewed include:

- 1) Installation of a sign on west face for new tenant (Snooze Mattress Company)
  - a. Note 1: welded metal support system previously approved for other tenants elsewhere on building
  - b. Note 2: As much as practical, anchor bolts and power conduit should be installed through mortar joints, not brick faces to minimize long-term weathering damage to the historic brick.

Notice of the approved application has been provided to building and zoning staff to facilitate the processing of any permits that are needed for the work.

Please note that work beyond that indicated in your permit application/correspondence requires additional approval.

If the approved work is not completed prior to the expiration date noted above, you may apply for an extension by contacting staff at least 30 days prior to expiration. Extensions may be granted for up to 12 additional months, based on a satisfactory staff review of the extension request.






