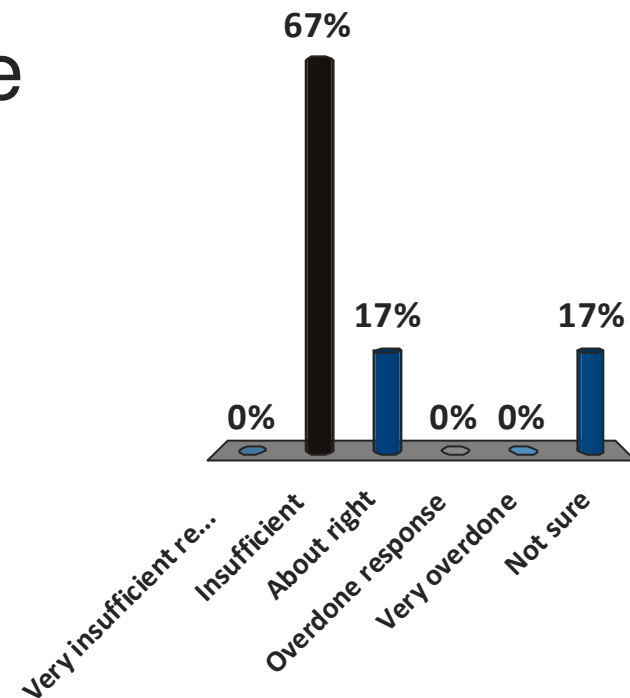

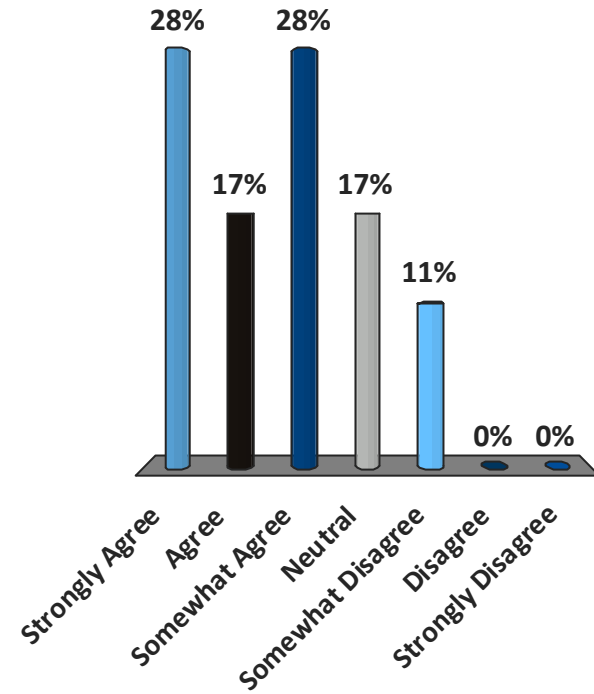

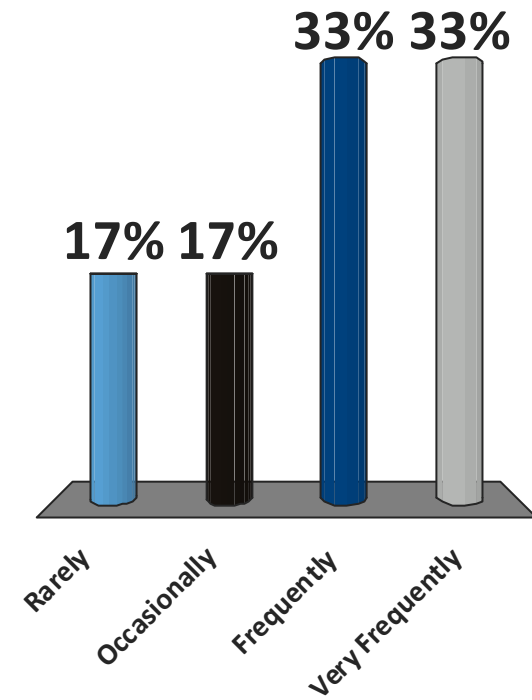

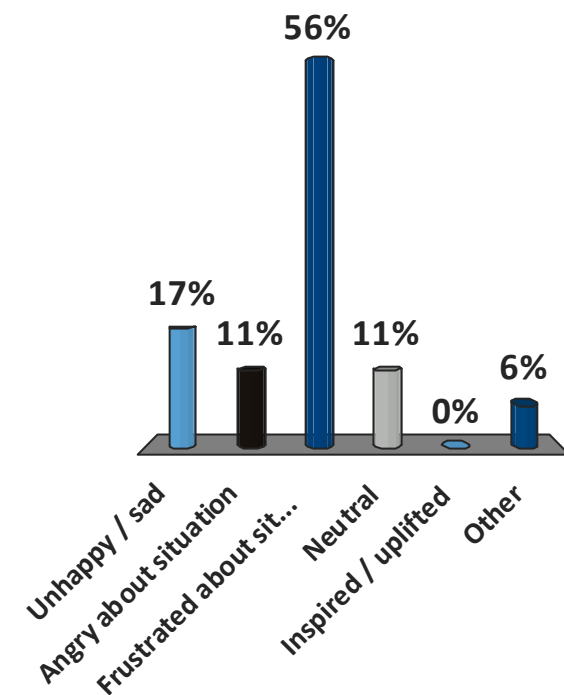
How often do you interact with people experiencing homelessness?

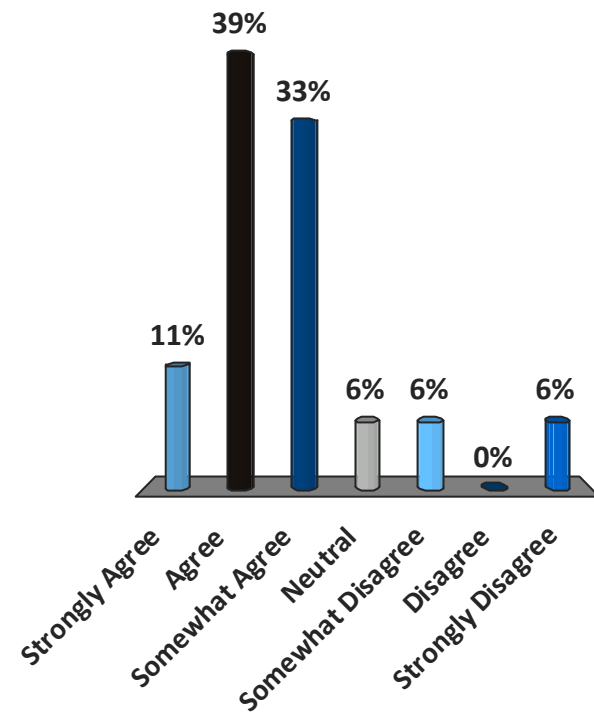

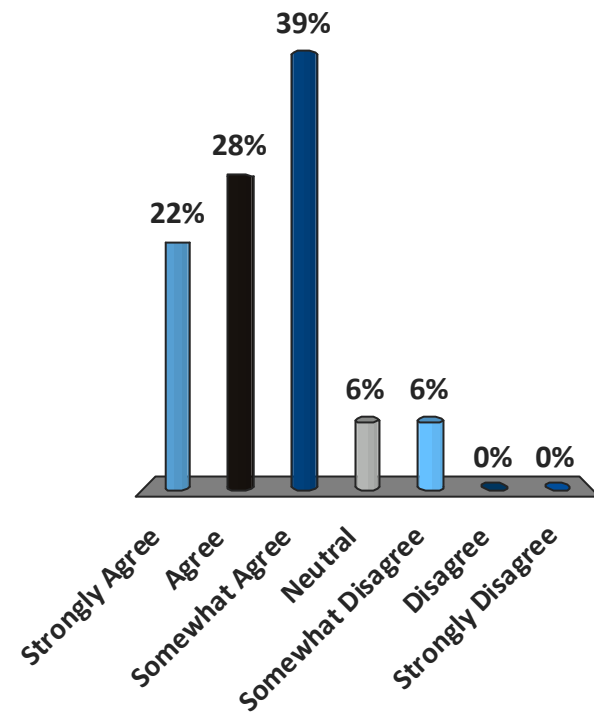
