### **Executive Summary**

### **Survey Background**

The City of Fort Collins Natural Areas Program continues to measure community perceptions and satisfaction with its program and the natural areas, and the recreation activities of visitors to the natural areas. The City contracted with National Research Center at Polco to conduct its third scientific survey of residents in Fort Collins and the rest of Larimer County, excluding Estes Park (the previous surveys were in 2011 and 2016). Of the 1,800 randomly selected households to which surveys were sent, 64 were identified by the post office as vacant. A total of 323 completed surveys were returned from the estimated 1,736 households that received a survey, for a response rate of 19%. Survey results in each geographic area were weighted so that respondent age, gender, race, ethnicity, and housing tenure status (rent versus own) were represented in the proportions reflective of the entire area. The margin of error is plus or minus five percentage points around any given percent for all results.

### **Survey Results**

#### As in past years, Fort Collins residents are more likely to visit natural areas compared to residents living in the rest of Larimer County, with a majority of all residents visiting at least once or twice a month.

Fort Collins residents were more likely to be frequent visitors, making more than 50 visits in a year (45%), than were those who lived in the rest of the county (22%), while only about 3% of Fort Collins

respondents said they never visit compared to 18% of residents outside of Fort Collins. Those who never had visited were asked to select the reasons why. About one-third of respondents cited lack of free time and 2 in 10 said they were not able to visit because of physical limitations.

Survey respondents in 2021 reported higher visitation rates (at least once or twice a week) compared to 2016, which could be due in part to the COVID-19 pandemic and quarantines, resulting in people spending more time outdoors.

### Hiking, enjoying the scenery, relaxing, and biking are the most commonly reported natural area activities.

About 4 in 10 survey respondents enjoyed dog walking and wildlife



viewing at the Fort Collins natural areas. Rates of dog walking increased in 2021, back to levels reported in 2011 (41% in 2021 vs 29% in 2016). The proportion of residents who enjoy the scenery in the natural areas has been trending up since 2011 (30% up to 69% in 2021).

Between one-quarter and one-third of residents also used the natural areas for running/jogging, commuting/passing through, and picnicking.

#### Residents voice appreciation of the existence of and proximity to natural areas.

Survey respondents were provided a list of seven potential reasons they might appreciate the natural areas provided by the City. About one-quarter of residents said that they most appreciated that they exist and

won't decrease (28%) and that they were nearby and accessible (21%). Just over 1 in 10 respondents also voiced gratitude for the number and variety of natural areas (15%), that the areas are not developed and serve as a buffer (14%), and that the trails make walking, biking, and running easy (11%). Compared to 2016, most ratings held steady; however, slightly more respondents in 2021 cited the fact that natural areas exist and won't decrease as a reason why they appreciate the natural areas. The proportion of people showing appreciation for the areas being well-maintained and preserved has been declining since 2011.

More than 90% of survey respondents said that access to a natural area was very or somewhat easy, however, not surprisingly, Fort Collins residents found them easier to access than the rest of Larimer County.

## User satisfaction remains high and the vast majority of residents feel safe when visiting natural areas.

As in 2016, about three-quarters of respondents were very satisfied with the natural areas they had visited, and 2 in 10 were somewhat satisfied. The proportion of residents who were very satisfied in 2021 was on par with 2016, and ratings were similar across the county. Additionally, nearly 9 in 10 reported not having had any unpleasant experiences in any City of Fort Collins natural area in the 12 months prior to the survey; a rating that was similar to past survey years.



Survey respondents provided a grade (A, B, C, D, or F) for 12 individual natural areas facilities and services. Between 70% and 95% of respondents gave grades of "A" or "B" to all facilities and services, with the highest marks going to trail conditions (95%), trailhead conditions (94%), and information provided in maps (90%). These were among the highest rated in 2016 and these grades were stable from 2016 to 2021. Educational activities and events received relatively lower ratings (70% gave a grade of A



or B) and declined from 2016; however, this could be due in part to in-person group activities being shut down during the pandemic. Grades for the number of restrooms saw a notable improvement from 2016 to 2021 (69% vs 80%, respectively).

A new question was added to the 2021 survey to gauge perceptions of safety while visiting Fort Collins natural areas. Two-thirds of respondents reported feeling very safe and about one-third felt somewhat safe. Only 4% reported feeling neither safe nor unsafe and 1% said they felt somewhat unsafe. No one said they felt very unsafe.

#### Recreational opportunities and wellness were considered by respondents to be the greatest contributions of the natural areas to the community.

Residents evaluated the extent to which natural areas contribute to each of a number of aspects of the community. At least three-quarters of respondents felt that natural areas contributed to a "great" extent to the recreational opportunities (81% of respondents) and wellness (75%) of the community. About 6 in 10 residents said that the natural areas greatly contribute to escaping the urban environment (64%), economic vitality (60%), feeling a connection to nature or for personal renewal (62%), overall quality of

life in Fort Collins (65%), and wide open spaces (61%). Generally, respondents were less likely to believe that natural areas contributed to a great extent to mobility (41%), educational opportunities (31%), and cultural resources conservation (46%).

Fort Collins residents were less likely to feel that the natural areas contributed to a great extent to many of the attributes listed compared to the rest of Larimer County, including escape from the urban environment, habitat conservation, scientific opportunities, and cultural resources conservation, among others.

More residents in 2021 compared to 2016 felt that the natural areas play a greater role in each of the following aspects: feeling a connection to nature or for personal renewal, scientific opportunities, escaping the urban environment, and a healthy environment/ecology.

#### **Natural Area Contributions to Community**

#### The Natural Areas website and word of mouth are where residents go to get information about natural areas.

Each of these were cited as a source by 4 in 10 respondents as a way to get information about natural areas. COTrex (Colorado trail explorer app) and social media were used by 39% and 29% of survey respondents to get information, respectively. Residents were less likely to use radio (7%), the Natural Areas booth at local events (7%), Natural Areas Enews (7%), and Engage (activity calendar and registration system, 9%).

Use of the various sources of information tended to be similar in both Fort Collins and the rest of Larimer County, with slightly more Larimer County residents using word of mouth to get information about natural areas in Fort Collins.

### **Appendix C: Comparison of Survey Responses by Year**

For comparisons among subgroups, the margin of error rises to approximately plus or minus 10% for subgroups of 100 and plus or minus 18% for subgroups of 30.

### Appendix D: Comparisons of 2021 Survey Responses by Respondent Characteristics

For ease of comparison between subgroups, some of the questions show summarized responses for only the proportion of respondents giving a positive answer; for example, the percent of respondents who were very or somewhat satisfied with the natural area they visited.

The subgroup comparison tables contain the cross tabulations of survey questions by selected respondent characteristics. Chi-square or ANOVA tests of significance were applied to these breakdowns of survey questions. A "p-value" of 0.05 or less indicates that there is less than a 5% probability that differences observed between groups are due to chance; or in other words, a greater than 95% probability that the differences observed in the selected categories of the sample represent "real" differences among those populations.

For each pair of subgroups that has a statistically significant difference, an uppercase letter denoting significance is shown in the category with the larger column proportion. The letter denotes the category with the smaller column proportion from which it is statistically different. Differences were marked as statistically significant if the probability that the differences were due to chance alone were less than 5%. Categories were not used in comparisons when a column proportion was equal to zero or one.

Items that have no uppercase letter denotation in their column and that are also not referred to in any other column were not statistically different.

For example, in Table 33 on page 37, respondents who had lived in Larimer County for 5 years or less (A) were statistically significantly more likely to visit natural areas 51 to 100 times a year (once or twice a week) compared to those who had live in the County for 6-20 years (B) or more than 20 years (C). This is indicated by the "B C" below the 31% of those who had lived in the County 5 years or less who selected "51 to 100 times a year". In another example in Table 35 on page 38, those who were aged 18-39 (A) and those aged 60 or older (C) rated their level of satisfaction with Fort Collins natural areas significantly higher than residents who were aged 40-59 (B).

### Highlights

Satisfaction with the Fort Collins natural areas visited was nearly universally positive among all demographic subgroups. Even when statistically significant differences were observed, the differences were small and not of "policy" significance. Likewise, the vast majority of respondents reported feeling of safe when visiting Fort Collins natural areas, and even differences that were statistically significant tended to be small.

While ratings of the ease of access to a natural area were also high, some differences between subgroups were greater than 7%; lower ratings were given by respondents who have resided in Larimer County 6-20 years, older respondents, respondents who identified as a race other than White, respondents with household incomes greater than \$100,000 compared to respondents who have resided in Larimer County for 5 years or less or for more than 20 years, younger respondents, respondents who identified as White, and respondents with household incomes less than \$100,000.
When asked to grade facilities and services in the natural areas, respondents who identified as a race other than White and those who identified as Hispanic/Latinx gave lower ratings to the condition of restrooms and to ecological restoration than did respondents who identified as White or who did not identify as Hispanic/Latinx. Additionally, those who identified as Hispanic/Latinx gave lower ratings to trash/recycling cans than those who did not identify as Hispanic/Latinx. Respondents who had resided in Larimer County longer than 20 years and older respondents gave lower ratings to the condition of trails and to directional information signs than did respondents with shorter residency in Larimer County or younger respondents. In addition, older respondents gave lower ratings to the number of restrooms, to trash/recycling cans, information provided in maps and ranger services than did younger respondents. Those who own their home gave lower ratings to the number of restrooms and to trash/recycling cans than did those who rent their home.

Younger respondents and respondents with a shorter length of residency in Larimer County were more likely to report hiking, running/jogging, community/passing through, relaxing/doing nothing and enjoying the scenery were activities in which they participated in Fort Collins natural areas than were older respondents and respondents with a longer length of residency. Younger respondents were also more likely to report biking, dog walking and kayaking/tubing/paddleboarding than were older respondents. Males were more likely to report fishing than were females, while females were more likely to report picnicking, dog walking and enjoying the scenery than were males. Respondents who rent their housing (who are probably younger) were more likely to report hiking, running/jogging, relaxing/doing nothing and enjoying the scenery than were respondents who own their housing (who are probably older than renters). Respondents who identified as a race other than White and those who identified as Hispanic/Latinx were more likely to report running/jogging, picnicking, and relaxing/doing nothing as activities than were respondents who identified as White or as Non-Hispanic/Latinx.

When asked what one thing they most appreciate about Fort Collins' natural areas, the top responses among all groups tended to be the fact that the natural areas exist and won't decrease or that they were nearby and accessible. One somewhat notable difference was that among those who rent their home and those who are younger than age 40 the second most frequently mentioned item after the fact that the natural areas exist was the number and variety of the natural areas, making the fact that the natural areas are nearby and accessible the third most appreciated facet of natural areas among these groups.

In general, respondents who identified their race as White or respondents who did not identify as Hispanic/Latinx were more likely to feel that natural areas contribute to the community in nearly all the ways considered on the survey than were respondents who identified their race as other than White and respondents who identified as Hispanic/Latinx. Those who have lived in Larimer County for a shorter time and younger respondents were more likely to consider that natural areas contribute to the recreational opportunities of the community and the quality of life in Fort Collins than were those who have lived in Larimer County for a longer time or older respondents. Respondents who have lived in Larimer County for a shorter time were more likely to feel natural areas contribute to wide open spaces than those who have lived in the County for longer time, while those who have lived in the County for a longer time were more likely to feel natural areas contributed to outdoor education than were those who have lived in the County for a shorter time.

When asked what information sources they use to learn about Fort Collins Natural Areas, respondents who have lived a shorter time in Larimer Count, and younger respondents were more likely to say social media than were respondents who have lived a longer time in Larimer County

or older respondents. However, those who have lived a longer time in Larimer County and older respondents were more likely to use word of mouth and newspapers than were those who have lived a shorter time in Larimer County and younger respondents. Younger respondents were more likely to have used the Natural Areas website or the COTrex app than were older respondents. Male respondents were more likely to use The Explorer and COTrex than were female respondents, while female respondents were more likely to have relied on word of mouth than were male respondents. Respondents who identified their race as something other than White and respondents who identified as Hispanic/Latinx were more likely to have used The Explorer than were respondents who identified their race as White and those who did not identify as Hispanic/Latinx. Those who identified as Hispanic/Latinx were more likely to have used social media as an information source than were those who did not identify as Hispanic/Latinx.

### **Appendix E: Survey Methodology**

#### **Developing the Questionnaire**

The City of Fort Collins Natural Areas Department desired to learn about community perceptions and satisfaction with its program and the natural areas, and the recreation activities of visitors to the natural areas. A similar survey was conducted in 2016 and 2011, and development of the questionnaire was undertaken by the agency's staff members, with input from survey scientists at National Research Center at Polco. For the 2021 survey project, some of the questions from the 2016 survey were retained, with minor changes to a couple questions, and several new questions were added. A copy of the questionnaire can be found in *Appendix F: Survey Materials*.

#### **Selecting Survey Recipients**

"Sampling" refers to the method by which survey recipients are chosen. The "sample" refers to all those who were given a chance to participate in the survey. Ideally, the chosen survey recipients should be representative of all eligible survey recipients. Randomly selecting survey recipients ensures that this will occur.

For the 2021 Fort Collins Natural Areas Resident Survey, 1,800 residents were randomly selected from within Larimer County, excluding Estes Park. A list of all households within the zip codes serving Fort Collins and Larimer County was purchased from Go-Dog Direct based on updated listings from the United States Postal Service delivery sequence file. The addresses were geocoded (mapped to a specific latitude and longitude) and compared to the boundaries of Larimer County, Estes Park and Fort Collins. Addresses identified as being in Estes Park or outside Larimer County were excluded.

Systematic sampling is a procedure whereby a complete list of all possible addresses is culled, selecting every Nth one until the appropriate number of households is sampled. This procedure was used to select 1,350 from within Fort Collins, and 450 from the rest of the County (excluding Estes Park). Multi-family housing units were oversampled to compensate for single-family housing unit residents' tendency to return surveys at a higher rate.

An individual within each household was selected using the birthday method. (The birthday method selects a person within the household by asking the "person whose birthday has most recently passed" to complete the questionnaire. The underlying assumption in this method is that day of birth has no relationship to the way people respond to surveys.)

In addition to the scientific, random selection of households, a link to an online open participation survey was publicized and shared via all available City communication channels. This survey was identical to the scientific survey and open to all City and County residents. The data presented in this report exclude the open participation survey data. These data can be found in the Supplemental Online Survey Results provided under separate cover.

#### Administering the Survey

Selected household addresses were processed for certification and verification, using use CASS<sup>TM</sup>/NCOA software that relies on the USPS National Directory information to verify and standardize the address elements and assign each a complete, nine-digit zip code where possible.

Each of these survey recipients were contacted by mail a total of three times in July 2021. The first mailing was a prenotification postcard announcing the upcoming survey was sent on July 1, 2021. About a week after the prenotification postcard was sent the first wave of the survey was sent. This packet included the questionnaire with a cover letter signed by Zoë Shark, the interim Director of the City of Fort Collins Natural Areas Department and a pre-addressed, postage-paid return envelope. This first mailing also included a map of all the Fort Collins Natural Areas, which was provided by the City. A week later a second survey was mailed, with instructions to recycle the survey if they had already responded to the first survey. Each invitation included a web link where respondents could complete the survey online if they preferred, and invitations were written in both English and Spanish so that those who preferred to complete the survey in Spanish could do so online. A copy of the survey materials can be found in *Appendix F: Survey Instrument*. Completed surveys were collected over the following six weeks. The online "opt-in" survey became available to all residents on August 2, 2021 and remained open for two weeks.

Of the 1,800 addresses selected to receive the survey, 64 were identified by the post office as vacant. A total of 323 completed surveys were returned, for a response rate of 19%. Of these 323, 248 were from Fort Collins residents (97 were collected online; for a total a response rate of 19%) and 75 were from the rest of Larimer County, excluding Estes Park (20 were online; a total response rate of 17%).

#### **Confidence Intervals**

The 95% confidence interval (or "margin of error") quantifies the "sampling error" or precision of the estimates made from the survey results. A 95% confidence interval can be calculated for any sample size, and indicates that in 95 of 100 surveys conducted like this one, for a particular item, a result would be found that is within a certain range if everyone in the population of interest was surveyed. The practical difficulties of conducting any resident survey may introduce other sources of error in addition to sampling error. Despite the best efforts to boost participation and ensure potential inclusion of all households, some selected households will decline participation in the survey (referred to as non-response error) and some eligible households may be unintentionally excluded from the listed sources for the sample (referred to as coverage error). Coverage error is very low for this survey, as the USPS delivery sequence file is used to select addresses, which has nearly complete coverage of all households.

For this survey, with 323 responses, the 95% confidence interval is about plus or minus five percentage points. The precision is when looking only at responses from those who live in Fort Collins, where it is plus or minus six percentage points, or for residents from the rest of Larimer County, where it is plus or minus 11 percentage points. Additionally, 398 residents completed the online open participation survey.

#### Survey Processing (Data Entry)

Mailed surveys were returned to NRC directly via postage-paid business reply envelopes. Once received, staff assigned a unique identification number to each questionnaire. Additionally, each survey was reviewed and "cleaned" as necessary. For example, a question may have asked a respondent to pick two items out of a list of five, but the respondent checked three; staff would choose randomly two of the three selected items to be coded in the dataset.

Once all surveys were assigned a unique identification number, they were entered into an electronic dataset. This dataset was subject to a data entry protocol of "key and verify," in which survey data were entered twice into an electronic dataset and then compared. Discrepancies were evaluated against the original survey form and corrected. Range checks as well as other forms of quality control were also performed.

NRC used Polco, our web-based civic engagement platform, to collect the online survey data. Use of an online system means all collected data are entered into the dataset when the respondents submit the surveys. Skip patterns or logic are programmed into the system so respondents are automatically "skipped" to the appropriate question based on the individual responses being given. Online programming also allows for more rigid control of the data format, making extensive data cleaning unnecessary.

A series of quality control checks were also performed in order to ensure the integrity of the web data. Steps may include and not be limited to reviewing the data for clusters of repeat IP addresses and time stamps (indicating duplicate responses) and reviewing response patterns to look for potential duplicate submissions. The online survey data were downloaded, cleaned as necessary and appended to the mail survey data to create a final, complete dataset.

#### Weighting the Data

One of the first steps in the data analysis was to statistically adjust the survey results so that the demographic profile of the respondents mirrors that of the population as a whole. This process is known as "weighting" the data. The primary objective of weighting survey data is to make the survey sample reflective of the larger population of the community. The socioeconomic profile of survey respondents was compared to estimates provided by the U.S. Census for adults in each of the two geographic areas (Fort Collins and the rest of Larimer County without Estes Park).

The variables used for weighting were a combination of respondent age, gender, race, ethnicity, and housing tenure (rent versus own). No adjustments were made for design effects. Results for the opt-in survey have been provided under separate cover. The results of the weighting scheme are presented in the following table.

The electronic dataset was analyzed using the Statistical Package for the Social Sciences (SPSS). For the most part, frequency distributions and percent positive (e.g., very or somewhat satisfied, very or somewhat safe) are presented in the body of the report. A complete set of frequencies for each survey question is presented in *Appendix A: Responses to Survey Questions*. Also included are results by respondent characteristics (*Appendix D: Comparisons of 2021 Survey Responses by Respondent Characteristics*). Chi-square or ANOVA tests of significance were applied to these breakdowns of selected survey questions. A "p-value" of 0.05 or less indicates that there is less than a 5% probability that differences observed between groups are due to chance; or in other words, a greater than 95% probability that the differences observed in the selected categories of the survey respondents represent "real" differences among those populations.
