#### **Application Instructions**

There are two rounds of this grant. Mobile Home Park residents, managers, or owners may apply.

Round 1: Applications are due by **March 1st** for projects that will take place in the Spring (Late March into June).

Round 2: Applications are due by **September 18th** for projects that will take place in the Fall (Late September through November).

## **Application Process**

Applications will be reviewed after the deadline.

Applications will be evaluated for--

- 1. Completion: the entire application is filled out
- 2. Explanation of intention and scope: your purpose for the grant funds and how funds will be used
- 3. Explanation of potential outcomes: who will benefit from the grant and what will the result(s) be

4. **Advancing equity:** awards will be dispersed widely throughout the City and Growth Management Area, reaching underserved residents of diverse backgrounds

Through a bid process, the City of Fort Collins has selected licensed contractors to complete project work. If awarded a grant, you will have the option to schedule the work with one of these contractors.

Contractors will ask you to sign a work completion form after the service is completed. Then contractors will invoice Neighborhood Services directly for payment.

Community awardees are NOT responsible for-

- 1) Submitting invoice or work completion form
- 2) Receiving money directly and paying contractors for awarded service
