

# City of Fort Collins Immigration Legal Fund 2025-2026 Request for Proposals

# 1. Overview/Background

# What is the Immigration Legal Fund?

The Immigration Legal Fund grant was approved as a pilot program by Fort Collins City Council in 2021 and received additional funding through the budgeting process to continue the program from 2023-2026. The Immigration Legal Fund provides funding to community partners, nonprofit organizations and/or legal service providers to offer residents wraparound, holistic immigration legal services to meet the most urgent needs, reach the greatest number of impacted community members, and build trust in the immigrant community. \$440,000 in total grant funding is available (\$220,000 per year in 2025 and 2026) to be used for immigration legal services is available from the City of Fort Collins through this competitive application process. Grants will be awarded under the Immigration Legal Fund for services from January 1, 2025 through December 31, 2026.

#### **Unmet Need in Fort Collins**

The estimated unmet need for legal services in Fort Collins is 75-100 detention and deportation cases per year and 400 per year for affirmative cases such as DACA, naturalization, or legal permanent resident cases. Through the Immigration Legal Fund pilot, grant recipients identified additional unmet need of at least 25 cases per year in need of legal services supporting victims of human trafficking, victims of crime, and victims of violence against women. Immigrant community members continue to emphasize that the lack of access to affordable legal services and representation are the biggest barriers to successful integration for immigrants in Fort Collins.

#### Fort Collins Immigrant Community Demographics

Fort Collins has an immigrant community of more than 11,000 people or 6.8% of the total population. Approximately 4,500 Fort Collins residents are currently not United States citizens. 2,200 residents are eligible for naturalization, and the remaining 2,300 non-citizen immigrants are estimated to be undocumented and at risk for detention and deportation. 15% of children in Fort Collins live with at least one immigrant parent and 75% of these children are themselves US citizens.

# 3. Scope of Work and Program Requirements

### Funds Awarded

Funds awarded may only be used to assist individuals who meet the following criteria:

- Are residents of the City of Fort Collins.
- Are asserting viable claims for relief, defense, change of status, right to lawfully remain, or other pursuit of pathways to citizenship and/or need advice of counsel on immigration or naturalization matters

# How can grant funds be used?

The City of Fort Collins grant funding for immigration legal services is available to service providers of the following:

- Removal defense for Fort Collins residents who are detained in any immigrant detention facility in the U.S. and those released from an immigration detention facility who have cases pending in Immigration Court.
- Affirmative relief and removal defense for residents of Fort Collins not in detention.
- Increasing local access to direct legal representation and capacity-building for local immigration legal services.
- Improving self-advocacy resources and access for Fort Collins residents in need of immigration legal services.

# 4. Legal Service Provider Requirements

- Who can apply for Immigration Legal Fund Grants?
  - o Nonprofit groups with 501(c)3 status in good standing with the IRS and State of Colorado
  - Community and advocacy groups
  - o Colleges, universities, and other institutions of higher learning
  - o Attorneys, law firms, Bar associations, or other legal professional organizations and practitioners

### **Applicants MUST:**

- Demonstrate a strong record of providing or outline a comprehensive plan to begin providing high-quality legal representation, support services, and education related to immigration legal issues
- ☐ Have licensed attorneys with immigration law expertise on staff or under contract who will directly provide the legal services described in this application or can demonstrate a recruitment plan and timeline to retain such services by qualified attorneys during the grant period
- Demonstrate that all professionals involved in providing services under this contract have the appropriate professional licenses and are in good standing with any applicable oversight agencies or professional organizations
- Demonstrate cultural competency and communication skills to consult with and/or represent clients regardless of identity, background, country of origin, or language(s) spoken
- □ Applicants must demonstrate a history of working with the Fort Collins immigrant community or detailed description of the applicant's interest in working with the immigrant community in Fort Collins. Organizations with related experience providing services to immigrant community members will be given priority.

# What are the grant reporting requirements for grant recipients?

Quarterly Reports must be submitted to the City of Fort Collins for services provided between January 1, 2025 and December 31, 2026. Metrics and a quarterly report template will be provided to grant recipients during grant contracting.

### Program Assessment & Final Reports:

In January of 2026 and 2027, grant recipients will work with City Staff to complete a comprehensive program assessment for that year. Grant recipients will be provided with the template during grant contracting and will include documentation of the following:

- □ Number of people receiving free legal advice, training, or other self-advocacy resources
- □ Number of people receiving direct representation (including age of the client and the case type)
- □ Status or outcomes of the cases or hearings
- □ Number of Fort Collins residents released on bond from an immigration detention facility during the program

### 5. Evaluation Criteria

• What will the grant review panel prioritize in selecting grant recipients? The grant review panel will be made up of immigrant community members, immigration and social justice advocates, and City Staff.

The grant review panel will prioritize applications that demonstrate the following best practices for publicly funded immigration legal services:

 Wrap-around, holistic services to meet the most urgent needs Examples:

for ineligibility (if known or reasonably ascertainable)

- Direct legal representation for the lifecycle of immigration cases
- An emphasis on legal services for deportation and detention cases
- Assistance with affirmative cases like DACA, SIJS, Asylum and Refugee Status, Visa Renewals, Violence Against Women Act protections, Family Petitions, Labor/Work Permit-Related Cases, Naturalization, Temporary Protected Status, Lawful Permanent Residency, and Family Reunification
- Adjustment of status
- Support through education and outreach for children unable to be reunified with their families
- Reach the greatest number of impacted community members
   Examples:
  - Support for legal pathways to citizenship and lawful presence through innovative direct and indirect engagement
  - Legal Advice & Consultations through legal clinics
  - Outreach materials and/or training for industries and employers working with immigrants under Work Authorization Programs

 Building trust in the immigrant community through ongoing self-advocacy and program support

Examples:

- Education and outreach that includes leadership and empowerment training to improve self-advocacy
- Focus on outcomes-based program metrics (program accomplishments like improvements in community safety) rather than output-based metrics (participant numbers or number of cases resolved)
- Know Your Rights Trainings in detention centers and embedded in local immigrant communities
- Intentional collaboration with other service providers to maximize impact Examples:
  - Formal partnerships to share resources and expertise
  - Coordinated referral networks to ensure seamless client support
  - Joint initiatives to address service gaps and enhance program reach

### "Local access and capacity building" may include, but are not limited to:

- Expanding the pool of pro bono and "low bono" immigration attorneys to provide services to Fort Collins residents
- Training and continuing education opportunities for attorneys and legal staff on current and emerging immigration issues and processes
- The use of law school clinics, law school graduate fellows, and law students to provide assistance to immigrants
- Other innovative projects that increase legal representation for immigrants

#### "Resident of Fort Collins" includes:

• Any individual who is currently a Fort Collins resident, which can be verified by appropriate and reasonable means (such as, but not limited to, mail addressed to and received by the resident at their Fort Collins address, ID card or student ID, vehicle registration, lease or mortgage documents, pay stubs)

#### "Removal Defense" includes:

- High-quality representation at all stages of immigration court proceedings
- Representation and legal support for master calendar hearings and bond hearings, detained removal, and non-detained removal after release
- Board and Immigrations Appeals (BIA) and remands from the BIA,
- State court proceedings related to immigration relief
- Transfer of venue proceedings, collateral proceedings incident to removal defense, and any costs associated with immigration-related defense
- Support services and/or engaging experts for testimony, assessment, or documentation

### "Self-advocacy resources and access" may include, but are not limited to:

- Community outreach and education materials, workshops, and presentations
- 'Ask A Lawyer' legal clinics
- Immigration legal services hotlines, call centers, and self-help centers
- Training and materials for community immigration advocates and "train the trainer" activities for community members
