Fort Collins Police are releasing the following information pursuant to Colorado Revised Statutes 16-13-901 through 16-13-905, which authorizes law enforcement agencies to notify the public of a sex offender's release when the offender has been determined to be a Sexually Violent Predator and is subject to community notification.

The purpose of this notification is to enhance public safety and protection. Vigilantism or the use of this information to harass, threaten or intimidate any of the following people is criminal behavior and will not be tolerated: offender, the offender's significant others or the community notification team.

The individual subject of this notification has been convicted of a sex offense that requires Law Enforcement registration. Further, he has been determined to present a high potential to re-offend and is therefore subject to community notification regarding his residence in this community.

This Law Enforcement agency has no legal authority to direct where a sex offender may live. Unless court restricts exist, he is constitutionally free to live wherever he chooses. Sex offenders have always lived in our communities, but they were not required to notify Law Enforcement of their residence until registration laws were implemented pursuant to the Jacob Wetterling act in 1994. Law Enforcement may now share that information with members of the public.
