

# REDUCED FEE PROGRAM

Did you know the City of Fort Collins Recreation Department offers reduced fees for income-qualified participants? The goal of the reduced fee program is to minimize financial barriers for low-income residents to participate in programs and access facility amenities.

## WHO CAN APPLY?

Those with a demonstrated financial need who are full-time residents of Fort Collins or reside within the Poudre School District boundaries.

## HOW CAN YOU APPLY?

Complete the attached application and include supporting documents, then return to any of our recreation facilities listed below. Please allow up to 10 business days for processing.

## WHAT ARE THE BENEFITS?

- Discounted Recreation Pass
  - Unlimited visits to Recreation facilities
  - Discounted activities throughout the Recreator

## PASSES – Purchase required to activate benefits

**\$40 Family Pass**; includes 2 adults and no limit on children in the same household

**\$25 Adult Pass**

**\$6 Youth/Senior (60+) Pass**

- Passes are good for one year from date of purchase.
- Must reapply to program every year.
- City Park Pool passes are sold separately.

## ACTIVITIES

- Beginner/Introductory classes receive a 90% discount.
- Intermediate level and all fitness classes receive a 70% discount.
- Advanced/Competitive classes receive a 10% discount.
- Ticketed events and other exclusions apply.
