

## **NON-PROFIT PROGRAM**

The City of Fort Collins Recreation Department offers a Non-Profit Program that allows access to two great offers. The Program discount applies to the following options:

#### Multiple Facility Admission Passes

The Multiple Facility Admission Passes allow access to Edora Pool Ice Center, The Farm, Foothills Activity Center, Fort Collins Senior Center, Mulberry Pool, and Northside Aztlan Community Center. City Park Pool is excluded from this pass.

The Multiple Facility Admission Pass is offered to qualifying non-profit organizations for \$1 per admission. The quantities available for purchase are 25, 50, and 100 admissions.

The details for use are as follows:

- Non-profit Passes are for client use only. The pass may not be used by an employee of the Non-profit organization.
- Attendants of non-profit clients are granted free admission.
- Once pass admissions are used, passes can be reloaded at any facility for the discounted rate.

### Fort Collins Senior Center Annual Membership

Non-profit groups may purchase an Annual Membership to the Fort Collins Senior Center for \$25. The Senior Center Membership gives the group access to only the following areas:

- Billiards Room
- Card Games
- Bingo
- Lobby Area

#### **City Park Pool Admission Passes**

The City Park Pool Passes allow access to City Park Pool during open season hours. The quantities available for purchase are 25, 50, and 100 admissions.

The Recreation Department requires non-profit clients to be with attendants at all times. Clients of any non-profit group cannot use the non-profit pass unless their attendant is present. There are no time restrictions for use at any facility; however, it is recommended that your organization use facilities prior to 3 p.m.

Organizational IRS proof of non-profit status or 501c3 determination letter must be submitted with completed application to be considered for approval. Non-profit organization status will be reviewed on an annual basis on May 1; each participating non-profit is required to submit their proof of non-profit status prior to May 1. If proof is not re-submitted by the due date, the Non-Profit Pass will be revoked until proof is supplied.

Non-profit organizations can submit their application and non-profit status to any Customer Service Representative at any Recreation Facility, excluding City Park Pool.
