RECYCLING MILESTONES

June 1, 1991 -- Ordinance requires trash haulers to provide recycling service (not "for free") to customers who desire the service.

December 1, 1992 - Larimer County Recycling Center opens.


January 1, 1993 - All trash haulers in Larimer County are required to charge customers for the amount of trash disposed. Flat fees are no longer allowed.

October 1, 1995 - Ordinance requires trash haulers to provide weekly recycling collection as part of basic trash collection service.

<u>January 1, 1996</u> - Ordinance requiring volume based rates becomes effective. Haulers permitted to establish a flat monthly base fee to recover fixed costs.

<u>December 1999</u> - Resolution adopted to increase City's waste diversion goal to a 35% rate by 2004, and a 50% diversion goal by 2010. <u>March 7, 2000</u> - Amendments made to the ordinance pertaining to procedural and document retention requirements.

April 20, 2004 - Amendment to ordinance clarifying that pay-as-you-throw system applies to group accounts, including homeowner associations.



GOAL INDICATOR: 80-90 Percent participation in residential curbside recycling services.

MEASUREMENT SOURCE: Semi-annual tonnage reports from local solid waste haulers, and 2000 census data from City Planning Department.


Curbside Recycling Participation: The number of single-family households increased by 2.9% during 2004, while the number of single-family households recycling at the curb decreased by 15% from December 2003 to December 2004.
