This report reflects Sales and Use Tax collected in June for economic activity that occurred in May. Please note the sales and use tax collected in June is predominately from May sales, but also includes delinquent collections from prior periods.

June Sales Tax Collected. In June 2023, sales tax collected in Fort Collins increased 3.5\% compared to June 2022. Sales tax collected totaled $\$ 12.4 \mathrm{M}$ compared to $\$ 12.0 \mathrm{M}$ in 2022.

June Use Tax Collected. The total use tax collected in June was \$1.7M, an increase of 3.7\% compared to June 2022.

Net Sales and Use Tax Collected. Total tax collected of \$14.2M was $3.6 \%$ higher than June 2022.

June Sales Tax Budget to Actual. In June 2023, sales tax collected in Fort Collins was $\$ 387 \mathrm{~K}$ less than budget.

June Use Tax Budget to Actual Excluding Rebates. In June 2023, use tax collected in Fort Collins was $\$ 72 \mathrm{~K}$ more than budget.

At the national level, May 2023 retail sales (as reported on June 15, 2023) increased by $1.6 \%$ compared to an increase in Fort Collins' sales of $3.5 \%$. May 2023 sales are the basis for the City's June 2023 sales tax collections and net taxable amounts (which are included in this report).

The Foothills Mall agreement outlines a base year of May 2012 to April 2013 to determine the core base sales tax $(2.25 \%)$ received at $\$ 1.8 \mathrm{M}$. Anything remitted to the City above that core base amount will be returned to the Metro District to support debt service. No tax is remitted to the Metro District until the base of $\$ 1.8 \mathrm{M}$ is reached. The chart above tracks both Core and Dedicated tax receipts for the period of May to April. As of June 2023, the year to date core amount collected is $\$ 368 \mathrm{~K}$ resulting in no tax due to the Metro District.

Sales Tax in the City's Downtown Area. The sales tax collected in June for the downtown area decreased $0.6 \%$ from the same period in 2022.

Lodging Tax Collections. The City collected $\$ 228$ K in lodging tax in June 2023. This was an increase of 22.6\% from June 2022.

Sales Tax Licenses. There were 13,323 active sales tax licenses at the end of June.
