This report reflects Sales and Use Tax collected in August for economic activity that occurred in July. Please note the sales and use tax collected in August is predominately from July sales but also includes delinquent collections from prior periods.

August Sales Tax Collected. In August 2023, sales tax collected in Fort Collins increased 6.0\% compared to August 2022. Sales tax collected totaled $\$ 12.8 \mathrm{M}$ compared to $\$ 12.1 \mathrm{M}$ in 2022.

August Use Tax Collected. The total use tax collected in August was \$1.9M, an increase of 1.7\% compared to August 2022.

Net Sales and Use Tax Collected. Total tax collected of $\$ 14.7 \mathrm{M}$ was $5.4 \%$ higher than August 2022.

August Use Tax Budget to Actual Excluding Rebates. In August 2023, use tax collected in Fort Collins was $\$ 202 \mathrm{~K}$ more than budget.

The Foothills Mall agreement outlines a base year of May 2012 to April 2013 to determine the core base sales tax $(2.25 \%)$ received at $\$ 1.8 \mathrm{M}$. Anything remitted to the City above that core base amount will be returned to the Metro District to support debt service. No tax is remitted to the Metro District until the base of $\$ 1.8 \mathrm{M}$ is reached. The chart above tracks both Core and Dedicated tax receipts for the period of May to April. As of August 2023, the year-to-date core amount collected is $\$ 756 \mathrm{~K}$ resulting in no tax due to the Metro District.

Sales Tax in the City's Downtown Area. The sales tax collected in August for the downtown area decreased $1.5 \%$ from the same period in 2022.

Lodging Tax Collections. The City collected $\$ 289 \mathrm{~K}$ in lodging tax in August 2023. This was an increase of 20.1\% from August 2022.

Sales Tax Licenses. There were 13,455 active sales tax licenses at the end of August.
