Figure 1. Budget to Actual - Sales and Use Tax Collected After Rebates

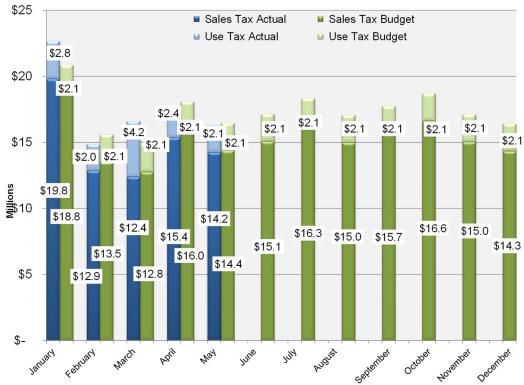


Figure 2. Sales and Use Tax Collected		May		Year to Date

May Sales Tax Collected. In May 2025, sales tax collected in Fort Collins decreased 3.7% compared to May 2024. Sales tax collected totaled \$14.2M compared to \$14.8M in 2024.

May Use Tax Collected. The total use tax collected in May was \$2.1M, an increase of 11.3% compared to May 2024.

Net Sales and Use Tax Collected. Total tax collected of \$16.3M was 2.0% lower than May 2024.

Figure 5. Budget to Actual – Sales and Use Tax Distribution

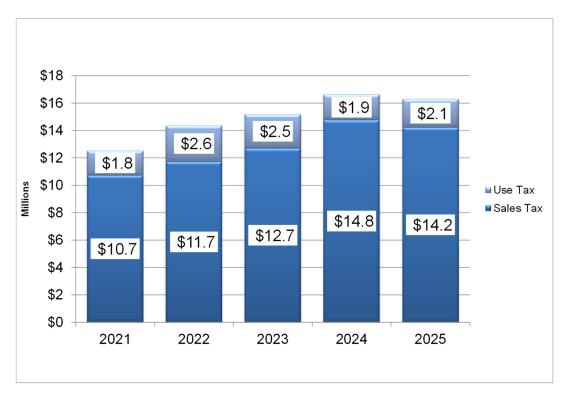

May Sales Tax Budget to Actual. In May 2025, sales tax collected in Fort Collins was \$153K less than budget.

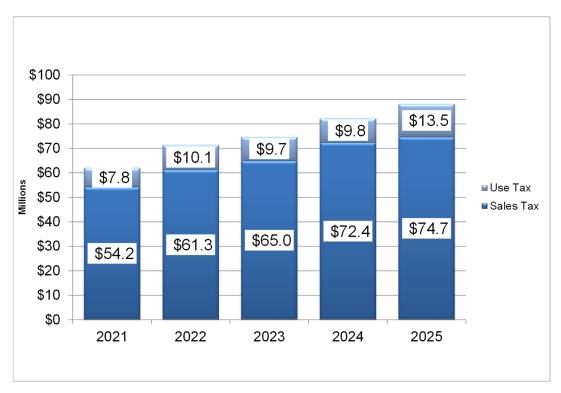
May Use Tax Budget to Actual Excluding Rebates. In May 2025, use tax collected in Fort Collins was \$18K less than budget.

At the national level, April 2025 retail sales (as reported on May 15, 2025) increased by 5.2% compared to a decrease in Fort Collins' sales of 1.4%. April 2025 sales are the basis for the City's May 2025 sales tax collections and net taxable amounts (which are included in this report).

Figure 10. May - Net Taxable Sales Subject to Sales Tax

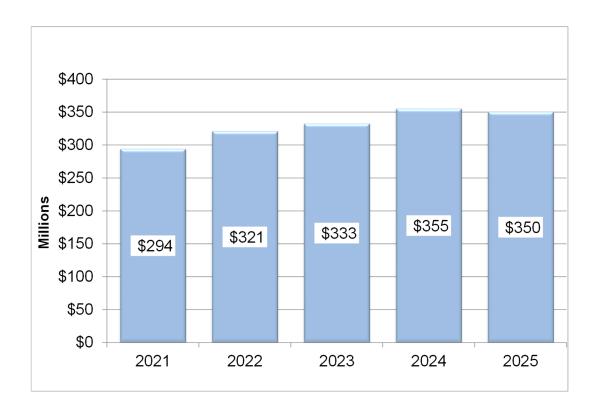


Figure 11. Year to Date - Net Taxable Sales Subject to Sales Tax

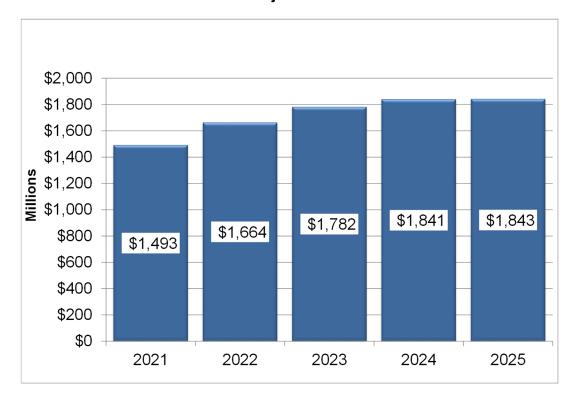
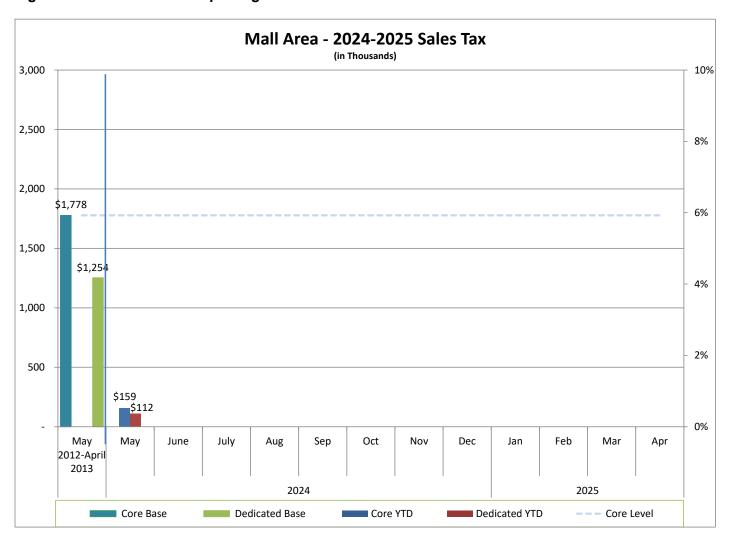


Figure 12. Metro District Reporting



The Foothills Mall agreement outlines a base year of May 2012 to April 2013 to determine the core base sales tax (2.25%) received at \$1.8M. Anything remitted to the City above that core base amount will be returned to the Metro District to support debt service. No tax is remitted to the Metro District until the base of \$1.8M is reached. The chart above tracks both Core and Dedicated tax receipts for the period of May to April. As of May 2025, the year to date core amount collected is \$159K resulting in no tax due to the Metro District.

Sales Tax in the City's Downtown Area. The sales tax collected in May for the downtown area increased 2.8% from the same period in 2024.

Lodging Tax Collections. The City collected \$157K in lodging tax in May 2025. This was a decrease of 4.7% from May 2024.

Sales Tax Licenses. There were 13,843 active sales tax licenses at the end of May.
