## Public Improvement & Retail Sales Fee Information

The Public Improvement Fee (PIF) and the Retail Sales Fee (RSF) are fees that are collected by retailers within certain areas of Fort Collins. Currently, these areas include the Front Range Village Shopping Center, Foothills Mall, The Exchange, and Harmony Commons. These fees are used to pay a portion of the cost for the public improvements surrounding these areas.

The PIF and RSF are fees and not a sales tax; therefore, the PIF and RSF are part of the purchase price and subject to sales tax.

The City of Fort Collins is not responsible for the collection of the PIF or RSF and does not receive any of the collections. Please contact the parties listed below for more information regarding their fees.
