Notice to Residents and Businesses In the Huntington Hills Area

PROJECT

Lafarge is scheduled to complete the final asphalt overlay in the Huntington Hills area as part of the 2011 Street Maintenance Program. Portions of your street will be closed to all traffic during the final overlay. You will not have access to your driveway or street during this operation. (See map on back)

SCHEDULE (SUBJECT TO CHANGE)

Work is tentatively scheduled to begin at 7:00 a.m., the week of July 11 (see map on back)

- Monday patching and utility repairs throughout area, Lafarge will also be working on a petromat system which
 extends the life of an overlay on Huntington Hills Court; you will have access to the street for travel and driveways
 however, parking will not be permitted on the street
- Tuesday (Phase 1) westbound Huntington Hills Drive/Court closed; residents on the north side please park in cul-desacs such as Ashton Court, Melrose Court, Normandy Court or Keswick Court
- Wednesday (Phase 2) eastbound Huntington Hills Drive, Melrose Court and Ashton Court closed; residents inside
 closure please park on Huntington Hills Drive west of Normandy Court which is the green highlighted area on map
- Thursday (Phase 3) eastbound Huntington Hills Drive, Normandy Court and Keswick Court closed; residents inside
 closure please park on Huntington Hills Drive either west of Dearborn Street or east of Melrose Court which is the blue
 highlighted area on the map

PARKING

Please remove all vehicles you intend to use during the day to an available parking area prior to 7:00 a.m. The towing procedure will begin at 7:00 a.m. for all cars that remain parked on the street. Please read the "No Parking" signs carefully to identify the exact date and times when your street/block will be affected by the final overlay. The placement of these signs shall take place at least 24 hours prior to the commencement of work.
