

## PROGRAM RULES

- Appliances must be for use at a Fort Collins Utilities service address.
- Toilet, showerhead and sprinkler rebates are for Fort Collins Utilities water customers only. Stormwater and wastewater only accounts, including ELCO and Fort Collins-Loveland Water District customers, are not eligible.
- Limit of two toilets, two showerheads, one clothes washer, and one of each sprinkler category per year.
- Purchases for rebates must be between Jan. 1, 2019, and Dec. 31, 2019. Submit application by Jan. 15, 2020.
- Verification of toilet recycling must be on application or by voucher.
- A copy of the itemized receipt must include model number, purchase price and date of purchase.
- Fort Collins Utilities reserves the right to verify the purchase and installation location.
- Rebate program is subject to change and available funds.
- Allow eight weeks for bill credit processing.
- Rebate not to exceed purchase price. Bill credit will be rounded down to the nearest dollar.
- Not eligible for new construction
