<sup>2</sup> New Renewables come from generation facilities that began commercial operation within the past 15 years.

For comparison, the current average mix of resources supplying Fort Collins Utilities Non-Renewable Subscribers includes: Coal (57.2%), Natural Gas (0.6%), Hydroelectric (18.8%), Renewables (14.2%) and Other (9.2% - unspecified purchases). This is based on the resource mix provided to Fort Collins Utilities by Platte River Power Authority for the year 2018 and includes Distributed City Renewables.

You will receive a monthly charge on the utility bill for Green Energy from Fort Collins Utilities.

How will my bill be calculated?

Green Energy costs an additional 2.65 cents per kWh, with PILOTS<sup>1</sup>. Green Energy is sold in blocks of 200 kWh or 100% of electricity usage for residential customers; and in blocks of 1,000 kWh or 100% of electricity usage for non-residential customers.
