

Eligible Facilities Request Worksheet

Purpose & Applicability

This worksheet is designed to supplement the Minor Amendment Application, and to document the information reasonably needed to determine if the applicant's request meets the requirements of an Eligible Facility Request (EFR) under 47 CFR § 1.6100 of the Federal Communications Commission (FCC) regulations. After Zoning Services reviews and approves these applications and associated materials, applicants will be eligible to submit a Building Permit application.
